## **Exploring DNA Pays Off**

My name is Jenny Webb. I am a descendant of Resolved White. I learned about my ancestral lineage about 5 years ago after I made the choice at age 62 to explore my DNA.

One day in January 2019, I reached out to an Ancestry member named Steve Hillis; I had a question about the confusion caused by so many "Ryderus/Ryderius" given names accumulating in my tree. I also mentioned Mariah Isabell Rice Gillham, my maternal 2<sup>nd</sup> great grandmother. My great grandmother was Leona Gillham DeBoard.

Mr. Hillis responded to my inquiry by indicating that he was a third cousin to a woman named Donna Crosby who lived in Seattle Washington; after reading my inquiry, he had reached out to Donna. Mr. Hillis then relayed a message to me that he had received from Donna: "Leona Gillham DeBoard was my grandfather's sibling and BOY, do I have some great news for Jenny!!"

Thence, I got in touch with Donna who was already a member of GSMD; due to her research she had already discovered our connection to the *Mayflower* White family. Thankfully, GSMD permitted me to piggyback off Donna's documentation, basically only necessitating the proof of my descent from Leona, the sister of Donna's grandfather.

In March of 2019, my DNA results were posted and I shared DNA with Donna! I am so thankful that I reached out to Steve Hillis and was connected to Donna Crosby. Besides discovering Donna, I also found another dear Whitedescended cousin, Heather DeBoard Haun.

Heather found me through a picture that I posted of our mutual 2<sup>nd</sup> great grandmother, Frances Leona Gillham. We learned that our grandparents were siblings. Before this journey, I knew nothing about either Donna or Heather; sharing information about our families and our heritage has been an experience to relish.

Currently, I am 66 years old; although retired, I am working part-time as a Speech-Language Pathologist. Enclosed is a somewhat outdated photo of me and my three sons, Adam, Zach, and Chevis, who are also descendants of the White line. Since I married for the first time at age 38, I am blessed with these youthful sons who are currently aged 26, 24, and 23, respectively.



I was so excited to learn and share with my family the newfound discovery that our ancestors were such an interesting part of American history; and, I am pleased to be a current member of the GSMD and TPWWS.

**W**hile the Pettingers as holders of the Manor have been erased in contemporary histories (Allan, *Susanna White-Winslow*, p.



43), in the 16<sup>th</sup> century they were among the elite of the community. (Sue Allan conversations with me). Sue added that contemporary Pettinger's still living in Tickhill would be surprised by the prominence of their family in 16<sup>th</sup> century. The interior of the church is

most historic of the churches that I visited. The church is extremely important architecturally. The bell tower is AngloSaxon except for the top story. This is a view of St. John's Apse


This Norman font would have been used for Mary Pettinger Jackson's baptism



on 11 September 1561 and her brother Edward's on 12 July 1563. Edward served as bailiff at Tickhill when Richard Jackson taught school there. Sue's research established their relation to their father John through

various wills. (Allan, Susanna White-Winslow, p. 37)

This photo shows the various modifications to the church – Note the



reflections of the church in the photo.

According to Sue Allan, the Chapel of St. Mary, where the Pettingers were buried. was located on the north side of the church. Unfortunately, their crypt is now lost because the chapel was removed as were most other chapels and chantries throughout England. Chantries were chapels donated by prominent persons and maintained for the perpetual prayers for their souls and of their families. In particular, Henry VIII had all chapels to St. Thomas removed. The Becket Chapel here was established in 1190 only twenty years after his martyrdom. Incredibly, the Becket altar stone with its intact lead sealed relics (below) was found in 1938. The altar stone

had been buried upside down; now the altar



has been restored in the church in the north aisle. The previous Becket Chapel houses the Books of Remembrance for those dying in the two World Wars and for those

lived and died in service to the church.

Richard Pettinger had leased the Manor and lands from Gregory Fiennes, Lord Dacre. Later, John was bequeathed the lease, but a new owner fought John's ownership. There were suits and countersuits. The outcome is unknown. Yet (Allan, Susanna White-Winslow, p. 41)

## Bad Day at Tea Rock

[Patrick sent us link to <u>Boston 1775</u> blog article titled <u>Bad Day at Tea Rock</u>, by author J.L. Bell, which recounts the story of Benjamin White (1725–1783) and his tea-burning in Marshfield prior to the Revolutionary War. Benjamin is descended from Peregrine. Mr. Bell, a Revolutionary War historian, gave us permission to use his article.]

**M**arshfield was unusually split in the last years before the Revolution. Some influential men supported the Crown, and some opposed it. Control of town meetings went back and forth, and the faction that

was outvoted in the official meeting would gather and grumble about the results.

One documented leader of the local resistance was Nehemiah Thomas (1712–1782), both treasurer and clerk for the town as well as a deacon at the meetinghouse. Another was Benjamin White (1725–1783), who sometimes filled in as clerk and would also represent the town in the Massachusetts Provincial Congress.

In late 1773 Marshfield got into a tussle over tea. The official side of that dispute is documented in the record of a town meeting on 31 Jan 1774 that protested the Boston Tea Party, and then a protest against that protest, both published in the Boston newspapers. However, there appears to have been more direct action in December, not described in writing until decades late. The first mention of this incident I've found was in Marcia A. Thomas's *Memorials of Marshfield* (1854):

While [Nehemiah Thomas was] absent, on one of these occasions, the whigs of the vicinity, in the ardor of their patriotism, took from his house, contrary to his intention, a quantity which had been seized by them and deposited there. This was burnt on a rock, near the meetinghouse, with much éclat. This was known afterwards as Tea Rock.

In the 13 Sept 1869 Springfield Republican, I found this:

A few rods from the Marshfield post-office is "Tea-rock hill."
During the revolutionary period all the tea was secreted in the entry of one of the colonists.
While he was at Boston, attending the Continental Congress [sic], a few ardent Whigs, who did not believe in the soothing qualities of tea bearing

a British tax, seized and burned it upon the hill's summit.

L. Vernon Briggs's *History of Shipbuilding on North River* (1889) devoted a footnote to the memories of Isaac Thomas (1765–1859), including:

He saw the burning of the obnoxious tea on the height which yet bears its name, and saw the torch touched to the fire fated pile by that devoted Whig, Jeremiah Low.

Thomas and Samuel White's family history published in 1895 stated:

Benjamin White was one of the committee to collect the tea after it was voted not to use it, and it was stored in Nehemiah Thomas's house. He did not feel satisfied with this, it looked as if saved for future use. When the Whigs of the vicinity, in the ardor of their patriotism, seized this tea, carrying it into a field near by, where there was a large rock which was "flat on ye top," poured the tea thereon, when Benjamin White and his brotherin-law, Jeremiah Low, two staunch old Whigs, God bless them! applied the torch with



much rejoicing. This was known ever afterwards as "Tea Rock."


## Thanksgiving Past, but Never Forgotten

## Peregrine's Role in Space By Ann Wilkerson

**P**eregrine: 1) noun, the son of William and Susanna White who was born on the

Mayflower

- 2) noun, a powerful falcon found on most continents, breeding chiefly on mountains and coastal cliffs
- 3) adjective, (archaic) coming from another country, foreign or outlandish
- 4) noun, the name of Astrobotic's lunar lander, which is at this writing orbiting the moon.

Both Resolved and Peregrine are unusual names, and when I heard my ancestor Peregrine's name on the news this week, it caught my attention.

The news was about the private space mission by Astrobotic, a Pittsburgh-based startup. After the spacecraft was launched on January 8, it developed issues due to a fuel leak and Peregrine will not now be able to land on the moon. Among the payloads on board are those of NASA, the German Aerospace Center, and the European Space Agency. Perhaps most of interest to non-scientists are the payloads containing



human remains and DNA. The remains include those of Gene Roddenberry and his wife and science fiction writer Arthur C. Clarke. DNA samples from three United States

Presidents were also being carried, in the form of human hairs of George Washington, Dwight Eisenhower, and John F. Kennedy. According to Livescience.com, now that the lunar landing is cancelled, Peregrine will become a "floating tomb."

The plan to put human remains on the moon was controversial. Navajo Nation President Buu Nygren appealed to NASA and the US Department of Transportation citing that the project would be "tantamount to desecration of this sacred space." Maybe the spirits heard his plea.


Florida) After several walks around we found Anna and so did her 10th Great Granddaughter-- our second grandchild Evelyn. The headstone was just the right


